



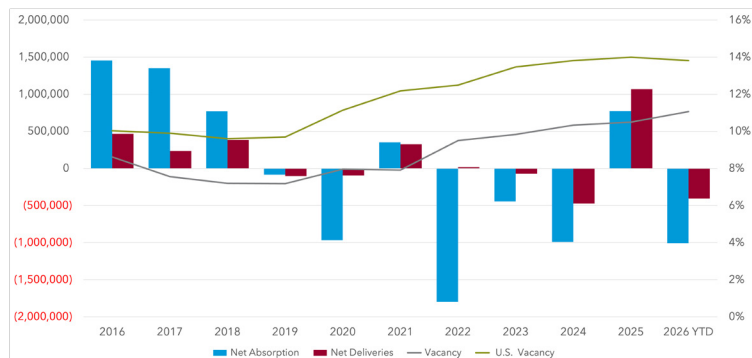
OFFICE MARKET OVERVIEW

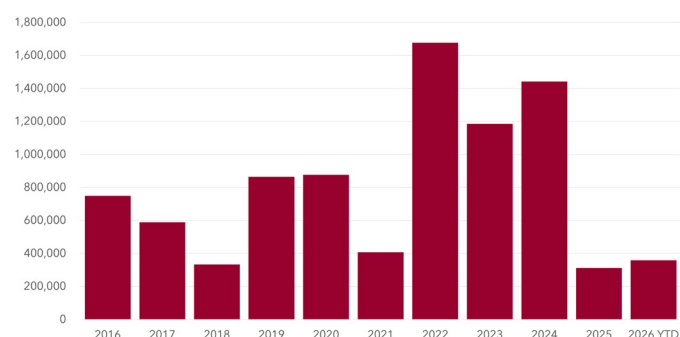
Cleveland's Q2 2026 office activity centered on a handful of moves rather than broad-based demand. Jones Day, the largest law firm in Cleveland, signed a 10-year lease extension for 382,019 SF at North Point Tower - stabilizing one of downtown's premier assets. Elsewhere, distress persisted: 800 Superior, the 587,118-square-foot former AmTrust headquarters, sold for just \$4 million to an affiliate of the Kassouf family, reflecting a trend of perceived bargains in the CBD. AmTrust is rightsizing, splitting into a renovated space at the AECOM Building downtown and 102,062 SF in Mayfield Heights. Gray Media Group is relocating its Cleveland stations from downtown's Reserve Square to Independence Technology Center, underscoring continued CBD-to-suburban migration.
